

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.579778 per \$100 valuation has been proposed by the governing body of RUNNELS COUNTY.

PROPOSED TAX RATE	\$0.579778 per \$100
NO-NEW-REVENUE TAX RATE	\$0.533897 per \$100
VOTER-APPROVAL TAX RATE	\$0.581997 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for RUNNELS COUNTY from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that RUNNELS COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that RUNNELS COUNTY is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 26, 2025 AT 9:30 AM AT Runnels County Courthouse, 2nd Floor Courtroom.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, RUNNELS COUNTY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Runnels County of RUNNELS COUNTY at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
