## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of 0.229072 per \$100 valuation has been proposed by the governing body of BALLINGER MEMORIAL HOSPITAL DISTRICT.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for BALLINGER MEMORIAL HOSPITAL DISTRICT from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that BALLINGER MEMORIAL HOSPITAL DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that BALLINGER MEMORIAL HOSPITAL DISTRICT is proposing to increase property taxes for the 2020 tax year.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

**Enhanced Indigent Health Care Expenditures** 

Indigent Health Care Compensation Expenditures: The Ballinger Memorial Hospital District spent \$337,057 from July 1 2019 to Jun 30 2020 on indigent health care compensation procedures at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigen health care expenditures is \$57,527. This increased the voter-approval tax rate by \$ .012968/\$100.
