The voter-approval tax rate is the highest tax rate that NORTH RUNNELS HOSPITAL may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that NORTH RUNNELS HOSPITAL is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on September 01, 2020 at 6:00PM at NORTH RUNNELS CLINIC BLDG. 7571 ST HWY 153 WINTERS TX.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, NORTH RUNNELS HOSPITAL is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the BOARD OF DIRECTORS of NORTH RUNNELS HOSPITAL at their offices or by attending the public meeting mentioned above.
