

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.585571 per \$100 valuation has been proposed by the governing body of RUNNELS COUNTY.

PROPOSED TAX RATE	\$0.585571 per \$100
NO-NEW-REVENUE TAX RATE	\$0.561420 per \$100
VOTER-APPROVAL TAX RATE	\$0.585571 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for RUNNELS COUNTY from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that RUNNELS COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that RUNNELS COUNTY is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 22, 2023 AT 9:30 AM AT RUNNELS COUNTY COURTHOUSE 3RD FLOOR COMMISSONER COURTROOM.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, RUNNELS COUNTY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the COMMISSIONER'S COURT of RUNNELS COUNTY at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

No-New-Revenue Maintenance and Operations Rate Adjustments

Indigent Defense Compensation Expenditures

The RUNNELS COUNTY spent \$70,902 from July 1, 2022 to June 30, 2023 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure and to fund the operations of a public defender's office under Article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For the current tax year, the amount of increase above last year's indigent defense compensation expenditures is \$5,510. This increased the no-new-revenue maintenance and operations rate by \$0.000364/\$100.
